

CONFIDO'S COOKIE NOTICE In force as of 03 April 2023

This cookie notice describes the cookies and other analogous technologies that are used on the <u>www.confido.ee</u> website and accompanies our Privacy Notice, which is available on the <u>www.confido.ee</u> website. Our Privacy Notice applies in regard to the parts that aren't regulated by this notice.

1. TERMS

2. TYPES OF COOKIES

2.1. The cookies that are in use on our website are categorised in accordance with their affiliation in the following manner:



First-party cookies	These are necessary for the website to function. These cookies are established by the website you are visiting and only that website can read them.
Third-party cookies	These are necessary to gather statistical data about your activity on the website or to show you personalised advertisements. These cookies are not established by the website you're visiting, but by a different domain; for example, Facebook, Instagram, YouTube, Google Maps, Google Ads.

2.2. The cookies that are in use on our website are categorised in accordance with the duration that they have been installed for in the following manner:

Temporary, also known as session-based cookies	These enable you to temporarily connect your activities within the same web browser browsing session, i.e. from the moment of opening the browser window until closing it.
Persistent cookies	These are stored permanently on your device for a specified time that is mentioned in the cookie, and they are activated each time you visit the website from which the cookie was installed. For example, persistent cookies are used to remember user preferences and choices. Persistent cookies are processed within 12-24 months following the user's last session.

Statistics cookies	These collect data about how the website is used in general and how you specifically use the website. For example, how many individuals visit the website, which website sections/features are visited the most often and which error messages people get while on the website. The collected data are aggregated and anonymised. The objective of these cookies is to improve the performance of the website.	
Advertising cookies	These cookies enable us to show you personalised advertising by usin the data gathered about your behaviour and interests. By usin advertising cookies, we show advertisements to the user that ar related to services offered by Confido or companies that belong in th same group with Confido.	
Preference cookies	These cookies enable us to remember your choices (e.g. text size, doctor and location preferences, shopping cart contents, etc.) and features (e.g. language or giving your consent to use the cookies, etc.) so that we can provide you with a more personalised and convenient experience when using the website. Only we can read the preference cookies.
